- Line 10 Amount taken from PWLB statement supporting January 2010 instalment, being Capital balance outstanding on the statement, 61,865-68, less the principal due as part of the Jan 2010 instalment, 1,292-78, rounded to 60,573.

Difference between Line 7 (70,583) and Line 8 (73,199) is 2,616, made up of Creditors of 3,938 less Debtors of 1,322.
