## 2. Reports by Clerk, Group Chairmen and Parish Council Representatives

Car Park, Toilets and Post Office: The toilets are fixed and in working order.

**Millennium Field and Jubilee Meadow:** Tree surgeons have been contacted regarding trimming back the trees around the lower dipping pond and cutting back the trees within the squash club embankment area. They have been out to the site and a quotation is awaited.

**Traffic, Pedestrians and Footpaths:** A meeting will take place with Cllr Hill and two representatives of Kent Highways on 30 January. The subject is currently unknown but the chairman has been advised that it may be to the council's advantage.

Lychgate: The church has approached Cllr Hill regarding help funding the drainage issues affecting the area around the lychgate

**Gordon Jones Playing Field and Play Area**: The quotation to extend the fencing has been accepted and the work will be carried out shortly.

The clerk is liaising with the squash club regarding access to the CCTV system.

Planning and Local Housing: Nothing to report.

**S27, S43 and Gladman development Working Grou**p: Nothing to report.

**Police Liaison and Neighbourhood Watch:** Fifteen crimes were reported in November 2017:

*Neighbourhood Watch:* It was reported that Neighbourhood Watch is advised of very few crimes by the police.

There have been several big crimes in Biddenden and nothing has been done by the police. The CSU Inspector is being asked what has happened on these cases and it will be reported back to Commissioner.

The CSU sergeant has been asked to get the PCSO to speak to a young person who is causing problems in the village.

**Tenterden Forum**: Cllr Friend will not be able to attend the next meeting on 28/2 and asked Cllr Tydeman if he was able to attend in his place.

**Community Project Fund:** Only one application has been received from the Horticultural Society in the sum of £100 for the purchase of plants for the display for Summer 2018. Cllr Friend is to ring members of the working group.

**Village Hall Management Committee:** A meeting to discuss future development plans will be held on 24/1. The Chairman or Cllr Bizley to attend.

Health and Safety: An inspection report was circulated.

**Allotments:** Notice has been given on one of the allotment plots. It will be offered to the next person on the waiting list.
